 - b. detention/amenity lake expansion and storm sewer to serve Kendall Lakes, Section 8; and
 - c. bond application no. 1.
8. Approve landscape maintenance agreement with homeowners association.
9. Authorize acceptance and/or conveyance of deeds, easements, and consents to encroachment, and abandonment of easements.
10. Receive report on development in the District, including financing agreements and assignments of financing agreements.
11. 2018 Directors Election, including:
 - a. adopt Resolution Designating an Agent of the Secretary of the Board of Directors During the 2018 Board of Directors Election Period;

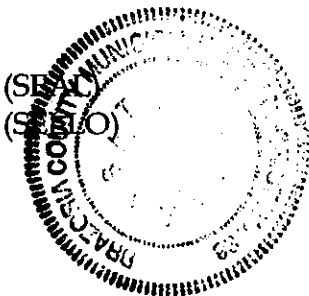
