  - b. Martha's Vineyard, Section 1, paving improvements for Cox Lane and SH 6.
5. Authorize acceptance and/or conveyance of deeds, easements, and consents to encroachment, abandonment of easements, and right-of-entry agreements.
6. Tax assessment and collection matters, including First Services Agreement.
7. Adopt Resolution Concerning Exemptions from Taxation.
8. Operation of District facilities.
9. Report regarding development in the District.

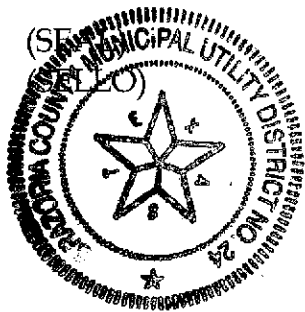
