


**MEETING NOTICE**

The District will consider and act upon the following matters:


1. Call to order, roll call, pledge of allegiance, opening prayer and welcome guests.

14. To review, discuss and take any necessary action regarding the development of fire, EMS, and/or other District facilities, including, but not limited to, receiving information and engaging professional services.
15. To review, discuss and take action regarding the acquisition of real estate for the development of fire and/or EMS facilities, including, but not limited to, receiving information and engaging professional services related to the selection of real property for emergency services facilities.
16. To review and take action on emergency services provider agreements.
17. To review and take action to revise emergency services provider funding including, but not limited to, additional operations funding, funding for grant matches, and capital advances.
18. To review and take action on emergency requests from providers for funds for, but not limited to, urgent repairs or replacement of equipment necessary to insure safety to providers and the public.
